Dear Sir/Madam,

You are aware that this Department has setup a 'Central Repository' of all ration cards/beneficiaries' data to facilitate the continuous national level de-duplication to avoid duplication of beneficiaries anywhere in the country for rightful targeting of food subsidy by correctly identifying the actual number of genuine beneficiaries/households in the country besides supporting the nation-wide portability of ration card holders under NFSA. Further, this repository would also ensure that new ration cards/beneficiaries are added only after proper de-duplication through the central repository.

- 2. On the basis of available data in the central repository, the de-duplication results being obtained are suggesting that many duplicate beneficiaries exist within same States/UTs as well as across different States/UTs. Thus, completion of de-duplication activity covering data of all the States/UTs is necessary. But so far, complete data has been shared with central repository only by some States/UTs, whereas many States/UTs have shared incomplete/partial data of some beneficiaries. 2 States of Chhattisgarh and Bihar have shared negligible data and 5 States of Tamil Nadu, West Bengal, Arunachal Pradesh, Assam and Meghalaya have not shared any information/data so far despite numerous follow-ups by this Department/NIC which is highly concerning. A State/UT-wise status of data availability is annexed.
- 3. It is also highlighted that the central repository will be continuously updated on a monthly basis through the key register of households/beneficiaries maintained by the respective State/UT.
- 4. It may be noted that the central repository would also form the basis for verifying beneficiary numbers in the AAY/PHH category in each State/UT for estimating the monthly foodgrains allocation under NFSA. It is therefore important that all States/UTs maintain a complete and updated database of all ration cards/beneficiaries in the central repository.
- 5. I would therefore request the above-mentioned States to immediately share their complete ration cards/beneficiaries' data with the central repository latest by 11th November 2019 without fail to avoid any inconvenience with regard to the allocation of food grains in the near future.
