**Subject: Request for relaxation in specification of Lustre loss in wheat RMS 2019-20 from Government of Uttar Pradesh -reg.**

Sir,

I am directed to refer to your letter No. 2345/अ०आ०वि/र०वि०व०-1/2019-20 dated 01.05.2019 and 02.05.2019 and letter No. QC. 2(3)/Uttar Pradesh Relaxation/2019-20 dt. 01.05.2019 of FCI, (H.Q.), seeking relaxation in specification of wheat for Rabi marketing Season 2019-20 due to unseasonal rainfall in various districts of Uttar Pradesh.

In order to reduce the hardship of farmers and to avoid distress sale of wheat, it has been decided to procure wheat in the districts of Uttar Pradesh with the following relaxation on provisional basis in the uniform specifications of wheat during the Rabi Marketing Season 2019-20 with immediate effect and till final analysis report of joint team is received.

i) Lustre lost wheat containing up to 10% affected kernels may be purchased without any value cut.

ii) The percentage relaxation in lustre lost wheat is allowed on district-wise basis as under:



(iii) Lustre lost wheat containing more than 10% and up to 50% affected kernels may be purchased with 1/4<sup>th</sup> of one value cut on flat basis.

iii) The wheat so procured shall be stacked and accounted for separately.

iv) Wheat stocks procured under relaxed specifications will be liquidated on overriding priority basis.
