
Sir/Madam,

This is in continuation to earlier communication of this Department w.r.t. integration of the Public Distribution System (PDS) services of all States/UTs with the UMANG App, to enhance the reach of PDS services so that 80 Crore beneficiaries are benefitted. Copy of aforesaid communication is attached.

2. In this context, as conveyed earlier, DBT Mission, Cabinet Secretariat, Government of India, is regularly reviewing the status of integration of the Public Distribution System (PDS) services of States/UTs with the UMANG App for further diffusion of e-services in a transparent manner and to ensure that all NFSA beneficiaries can avail the DBT/PDS benefits. Recently, a review meeting held on 7th & 8th July 2022 under the Chairmanship of Joint Secretary, DBT Mission in this regard. Sir/Madam,


This draws reference to the periodic review meetings conducted by the DBT Mission, Cabinet Secretariat, Government of India, to review the status of integration of the Public Distribution System (PDS) services of all States/UTs with the UMANG App.

2. Accordingly, NIC HQ is onboarding the identified PDS services of the States/UTs which are running the NIC's Common Application Software (CAS) modules. In this regard, NIC HQ has shared the required API document with all CAS States/UTs for their approval. These States/UTs, are therefore, requested to provide their consent and approval for the said API at the earliest, to enable them to expeditiously integrate their PDS services with the UMANG App. A copy of the approval may also be shared with this Department.

3. Further, all other States/UTs are also requested to direct their respective State NIC Units/ Technical Partners to expedite the work for the said integration of their PDS services with UMANG App so that it can be completed in a time bound manner at the earliest. These States/UTs may also provide necessary approvals, wherever required by their respective technical partners, for the purposes of said integration.
