I am directed to refer to this Department's letter of even number dated 02.06.2020 and to say that the scheme of "Integrated Management of Public Distribution System (IM-PDS)" is a fully funded by the Central Government for implementation during 2018-19 and 2019-20, which has been extended by a period of one year up to 31-03-2021.

2. This Department has already released first instalment of financial assistance under the scheme to your State/UT. The conditions for release of second instalment of financial assistance are given below:

It is, therefore, again requested that the proposal for releasing second installment of financial assistance may be furnished on priority within one week along with the Utilization Certificate (UC) at the earliest. Status of fulfillment of requisite conditions mentioned in para 2 above may also be furnished supported by relevant information/ documents in the prescribed formats.

4. As the release of funds are to be done as per the Monthly Expenditure Plan (MEP) and Quarterly Expenditure Plan (QEP), the regulation of fund release becomes difficult in FY 2020-21. In order to avoid this situation it is requested to send the proposals at the earliest enabling this Department to chalk out the release(s) accordingly.

5. It is also requested that complete details of SPMU and DPMUs deployed in the State/UT may be furnished in the prescribed proforma attached on a monthly basis (every first week of the month).
