Subject: Adoption of 'DigiLocker' for ration cards in Public Distribution System (PDS) - reg.

Sir/Madam,

The undersigned is directed to refer to the OM of the D/o Administrative Reforms and Public Grievances (DARPG) dated 28.12.2020 and DO of CEO (NeGD), MeitY dated 15.12.2020 (copies enclosed), and to state that, 'DigiLocker' facility has been introduced by the Government of India for the use of citizens to preserve the authentic digital copies of various documents, certificates, etc. issued to them by Government agencies and other entities. This facility enables anytime, anywhere access of the digitally verified documents by the citizens as well as a number of service providers/verifiers without the need of any physical documentary interface. The current COVID-19 situation has also amplified the reliance on digital platforms equally for the citizens/beneficiaries as well as Governments/service provides and to promote paperless citizen-centric service deliveries.

- 2. As per the instruction of DARPG, it is mandatory for all Government Ministries/Departments delivering citizen services to integrate their systems with DigiLocker for the issuance and verification of documents to the citizens/beneficiaries in a time-bound manner to enable hassle-free and friendly citizen service deliveries by various public authorities. Besides, in view of the One Nation One Ration Card (ONORC) plan, the CEO (NeGD) has also advocated the adoption of DigiLocker in Public Distribution System (PDS) for making ration cards available through this facility, so that beneficiaries can easily access their e-Ration Card anytime, anywhere in the country under ONORC. This will also reduce the hassles of migratory beneficiaries against the threat of stolen, lost or damaged/soiled ration cards.
- 3. Since, ration cards are issued by the State/UT governments, it is requested that necessary action may be initiated to integrate the respective ration cards data with DigiLocker at the earliest. Necessary technical guidance and support for shall be available from NeGD (National eGovernance Division) under the Ministry of Electronics & Information Technology (MeitY).
