Subject: Pending utilization and claims of Central Assistance under the scheme of “End-to-End Computerization of TPDS Operations” – reg.

Sir/Madam,

As you are aware that this Department is implementing a scheme on ‘End-to-End Computerization of TPDS Operations’ on cost sharing basis in collaboration with all State/UT Governments. As informed earlier, the Government has extended the validity of the scheme up to March, 2020 without escalation in the total project cost of the scheme to allow the States/UT to complete all activities under the scheme. It was also informed that no further extension will be given in any case whatsoever.

2. In this regard, a State/UT wise statement showing the financial outlay for the implementation of the scheme, giving details of the central assistance released by this Department so far, its utilization by States/UTs and the State matching share released by the States/UTs is annexed.

3. States/UTs are requested to kindly verify the financial details appearing in the Statement and in case of any discrepancy may immediately intimate to this Department with proper supporting documents, specifically in respect of the amounts utilized, unspent balance and release of State/UT matching share under the scheme. Pending utilization certificates against the unspent balance of Central Assistance may also be submitted to this Department in required formats at the earliest.

4. Further, States/UTs are also requested to submit their proposals to this Department for the release of 2nd/3rd installments, as applicable, along with the requisite documents in support of fulfillment of all mandatory conditions to this Department. Some States have already submitted their proposals for the release of 3rd and final installment of Central Assistance. Their proposals are under processing and in case of any deficiencies are found, separate communication is being initiated with the concerned State through emails/letters.

5. An early action as per above may please be taken and any pending activities, in fulfillment of mandatory conditions for the release of balance Central Assistance, as applicable to the State/UT, may also be completed without losing any further time, as the scheme will come to an end in just a few month's time.
