Please refer to Department's letter of even number dated 21.07.2020 on the subject mentioned above and to say that Secretary (Expenditure), Ministry of Finance has impressed upon the Ministries/Department of Central Government to exercise greater financial discipline and control over the expenditure under the Central Sector Schemes/Projects, keeping in view the financial constraints being faced by the economy.
