Subject: Record of discussions during the meeting of the Standing Finance Committee (SFC) on the proposed extension of the scheme on 'Integrated Management of Public Distribution System (IM-PDS)' held on 22-10-2020 under the Chairmanship of Secretary (F&PD)

- 1. A meeting of the Standing Finance Committee (SFC) was convened under the chairmanship of Secretary (F&PD) on 22-10-2020 at 3:00 PM in Conference Room No. 167, Krishi Bhawan, New Delhi on the proposal for extension of validity of the Scheme on "Integrated Management of Public Distribution System (IM-PDS)" by one more year i.e. up to 31-03-2022 without escalation in the total cost of Rs. 127.3 Crore.
- 2. The members of the Committee / representing officers from NITI Aayog and MeitY joined the meeting through Video Conferencing. Complete list of participants to the SFC meeting is at **Annex-I**.
- 3. Initiating the discussion, it was informed to the committee that an SFC Memorandum along with requisite details/annexures was circulated by the Department to all members of the committee along with the meeting notice on 15-10-2020. Further, to facilitate the discussion of the SFC, a brief power-point presentation on the proposed extension of the IM-PDS scheme, giving key details of scheme, physical progress, achievements, road-ahead/future deliverables and financial position was made by the Department. Copy of the presentation is at **Annex-II**.

<u>Discussion with committee members / representing officers:</u>

- 4. **NITI Aayog:** Sh. Yogesh Suri (Sr. Advisor, NITI Aayog) while acknowledging the significance of the scheme in the implementation of national portability of ration cards through One Nation One Ration Card plan recommended the extension of the scheme as proposed by the Department. Further, Joint Secretary (BP,PD) while clarifying the query of Sh. Yogesh Suri informed that under One Nation One Ration Card plan, the beneficiaries can lift their food grains from any ePoS enabled FPSs in the country by using same/existing ration card through biometrically authenticated transactions. Sh. Suri also suggested the Department to devise some relevant penalization mechanism for the States/UTs defaulting on the implementation of IT/technology-based initiatives/reforms, may be deduction or withholding of intra-State transportation or other central assistances and shall be made besides the criteria of additional borrowing of GSDP by M/o Finance.
- 5. **MeitY:** Smt. Uma Chauhan (Scientist-G), raised a query with respect to the component wise expenditure made under the scheme and on the publicity and awareness of One Nation One Ration Card plan. Department clarified that the financial position through slide in PPT and informed that the details of expenditure

made under the scheme so far, as releases to States/UTs (for SPMU/DPMUs), NIC/ NICSI/CPMU have been share with the SFC memo at Annex-III circulated earlier. Further, responding to the query regarding reappropriation of funds for Publicity & Awareness, it was informed that such reappropriation of funds may not be required as it is not a component under the scheme. Further, the representing officer of MeitY requested to share the copy of presentation.

- 6. **D/o Expenditure**: Ms. Divya Bharathan, Dy. Secretary, D/o Expenditure telephonically informed Director (PD), that the I.F. Division of the Department is authorised to represent as the outlay of IM-PDS scheme is below Rs. 300 Crore.
- 7. **I.F. Division:** Sh. KMS Khalsa, (DS-Fin, D/oFPD) raised the following three concerns
 - a. Prior circulation of SFC memo with the committee members and collation of their comments and review of IFD: It was informed that similar procedure of bringing the matter before SFC, i.e. on the basis of recommendation of Empowered Committee and bypassing prior consultation with IFD or line Ministries/Department, as followed during the last extension of the of the Scheme during SFC meeting, has been followed now.

 However, Secretary (DFPD) desired that since SFC is the highest appraisal/decision-making body, in such cases, prior consultation with Ministries/Departments and IFD may be ensured in future.
 - b. Discrepancy regarding sanctioned manpower under the NIC head in the table given at point no. 4.1 (c): The sanctioned strength was enhanced from 37 to 43 in Nov 2017 under this head, which should have been reflected in the current SFC Note. Though the revised sanctioned strength has been correctly reflected in the Annexure to the SFC Note. However, taking note of this observation, the position is clarified again herewith at Annex-III.
 - c. Expected shortfall of funds for continuation of CPMU: As highlighted by DS(Fin) that provisioned funds under CPMU head may exhaust by December 2020, it was clarified from the financial position (in slide no. 10 of the PPT) that the shortfalls under the NIC/NICSI/CPMU heads may be met from the estimated 6 Cr. savings from the States/UTs head and Rs. 3.2 Cr. under NIC/NICSI head, and the Program Division may request concurrences of IFD for the re-appropriation of these funds, as and when required.
- 8. It was also clarified to the committee that funds for continuation of SPMUs/DPMUs during 2021-22 (extended year) shall be released to the States/UTs in two installments of 50%-50% each.
- 9. Responding to the query of representing officer from MeitY, Joint Secretary (BP,PD) also clarified that the physical progress of this scheme has been much faster and higher than the financial progress, and depending upon further availability of funds under the scheme and if required, the Department may again propose to extend the validity of the scheme beyond March 2022.

10. While summing up the deliberation made during the meeting, Secretary (F&PD) confirmed from all the committee members regarding any objection to the proposed extension of the scheme. Since, no objections were raised by any Committee Member, the scheme on Integrated Management of Public Distribution System (IM-PDS) has been recommended for extension for one more year beyond 31.03.2021 up to 31.03.2022 without escalation in the total project cost of the scheme.

The meeting ended with a vote of thanks to the chair.



1. Dedicated IT (Data Centre) Infrastructure is setup at NDC, Bhubaneswar under the IM-PDS scheme.

Central Repository of Ration Cards:

- 1. Ration card data of ~73.13 Cr. beneficiaries (>90% NFSA population) is available in Central Repository.
- 2. West Bengal has not yet share their NFSA ration cards data.

National De-duplication:
